Overview

- · Provides support to current associates and/or their immediate family members
- Maximum assistance of \$5,000 US0 (or local currency) per application. For international applications the assistance will be granted in local currency, with consideration given to local cost of living · Eligible emergencies, include but are not limited to:
- <u>COVID-19 pandemic</u>
 <u>natural disasters</u> flood, hurricane, tornado, fire
- <u>national disasters</u> as declared by the US President (or appropriate national leader)
- medical hardships depletion of insurance, expenses that don't qualify for insurance coverage, etc
- <u>family crisis</u> personal or financial hardship brought on by unusual circumstances beyond the family's control

· While not required, applications which attach documentation evidencing such emergencies (photographs, insurance claims, receipts, bills, etc.) is preferred. Exceptions shall be granted on a case by
