

	Express Collection	Standard Collection	Advanced Collection
Scope	Targets text messages and certain applications on mobile devices.	Methods like iCloud backups or native Android user data.	Full mobile device collection.
Method	Remote collection using a client utility or app.	May require physical kits or more custodian cooperation.	Physical collection only.
Use Cases	Quick, targeted collection of text messages and supported apps.	Specific data collection, less comprehensive.	Comprehensive forensic preservation, and detailed analysis.
Cost and Time	Faster, less intrusive, and less expensive.	Can be faster and less expensive, especially for specific data.	Longer and more expensive due to comprehensive nature.
Data Types Collected	Text messages and supported apps like WhatsApp, WeChat, etc. on Apple iOS devices.	Varies, but may not capture all data on the device including operating system artifacts, ephemeral messaging data, and stored email.	All data on the device, including underlying databases, ephemeral messaging data, and operating system artifacts.
Custodian Involvement	Requires custodian to install an app or use a client utility.	Depending on the solution, some higher level of custodian involvement may be required.	Minimal, as it requires onsite or lab-based work.
Geographical Flexibility	Can be used anywhere in the world, with data centers in the US and UK.	May be limited by the need for physical kits, custodian cooperation, and regional privacy laws.	Can generally be used in North America, Europe, Latin America, and other countries with certain restrictions.
